Terms of this Agreement:

By purchasing a puppy or dog online, sending a payment or presenting payment to the Seller, the Buyer understands that they are agreeing to purchase a Chihuahua and that the animal has been given first shots. The Buyer will be presented with a State Health Certificate (if shipped) and registration papers (if applicable). Seller certifies that this puppy was bred in accordance with The American Kennel Club (AKC) registration requirement for purebred dogs. Breeder has made application to AKC for litter registration, and individual dog papers will be issued to the Buyer. The Buyer agrees to take full responsibility and ownership for the dog at the time of sale and understands the following: 1) If the puppy or dog qualifies for AKC registration it is the sole responsibility of the Buyer. 2) The Buyer understands that State and Local Laws regarding additional dog vaccinations and any necessary licenses should be complied with and are the sole responsibility of the Buyer. 3) The Buyer agrees to assume all responsibility for the health, well-being, actions and care of the animal at the time of sale. The Seller shall not be held responsible for any subsequent illness, death or damage that might occur to the dog once the sale is complete (when all monies have been paid to the Seller) and the dog may not be returned for any reason to the Seller. All sales are 'as is' and final. 4) The Buyer agrees that the Seller has informed them of the following: Chihuahuas are toy dogs that should not be handled roughly. If exhausted by over-play, Chihuahua Puppies may suffer from low blood sugar and require immediate treatment. Chihuahua puppies have a soft spot on the tops of their heads, which can cause damage or death if the animal is hit there. Chihuahuas are warm weather dogs that should not be exposed to temperatures below 45 Degrees Fahrenheit without protection against the cold. The Buyer is purchasing this puppy with the understanding that Chihuahuas De Moore offers a limited health guaranty or warranty (see below), all sales are final and no refunds or returns are possible for any reason. As puppies grow, size and color may not always be what's anticipated. We make no guaranty with regard to unanticipated size or color changes. Chihuahuas De Moore reserve the right to cancel any purchase and refund the customer or refuse a purchase if they feel it threatens the well-being of a puppy. If a puppy cannot be delivered because it is no longer available or has not passed a health exam given by our Veterinarian, the Buyer will receive a refund within thirty days of the shipping or delivery date. In that case, the buyer may instead choose another puppy from our website or will be sent pictures of another puppy to replace that one and may accept or reject the replacement before delivery. Once delivered, no returns or refunds are possible. By purchasing a puppy or dog from Chihuahuas De Moore, the Buyer agrees to all of the terms of this agreement.

HEALTH GUARANTEE: As can be reasonably determined by veterinary evaluation, the Seller certifies that this puppy is, to the best of his knowledge, healthy at the time of sale. Vaccination records and a health certificate will be provided by the Seller, which includes information on diet, shots, worming, bathing, and any other treatments given this dog. The buyer is encouraged to have this puppy examined by a state licensed veterinarian within 72 hours of purchase, at buyer's expense. If this dog is determined to have a major health defect, he/she may be returned to the seller for a full refund. If the pup has any health problems/illness during the first 30 days from the purchase date, Buyer has the right to return the dog to Seller (Buyer pays shipping) for credit in the amount of the purchase price toward the acquisition of another pup from Seller; or for a refund of the purchase price (less shipping). This refund policy does not cover death due to neglect nor abuse.
